

The client purchased the aircraft to use for corporate purposes, partly flying into the EU. They therefore required the aircraft to be able to operate into and throughout European airspace with free circulation import status.

Working closely with the client's professional advisers, we established a tax-efficient holding structure for the aircraft and registered it for VAT purposes in the EU. We made arrangements for the direct importation of the aircraft to secure appropriate and permanent EU import documentation acceptable across all member states. We continue to provide all necessary accounting and VAT reporting for the structure on an ongoing basis.

#2 - Bombardier Challenger 350 to be offered for charter

The Plane

The Bombardier Challenger 350 is a super midsize business jet worth around US\$26 million. It was the second best seller of 2017 and a worthy successor to the 14-year-old Challenger 300.

The Client

One of Europe's leading independent retailers.

Their Goal

The client had purchased the aircraft for their own business use purposes, but also wished to be able to offer it for charter to third parties. They therefore required the aircraft to be commercially registered, placed with an Air Operator Certificate (AOC) company, and to be able to operate into and throughout European airspace with free circulation import status.

Again we established a suitable holding structure for the aircraft and registered it for VAT purposes in the EU. We made arrangements for commercial aircraft registration status, placement of the aircraft with an AOC charter management company, and direct importation to secure appropriate and permanent EU import documentation acceptable across all member states.
